Company Overview

AMX Argentina, S.A., a mobile network operator, provides wireless telecommunication services through its Claro brand (previously known as CTI Móvil). It offers wireless, fixed-line voice, broadband, and Pay TV services and products. AMX Argentina, S.A. was formerly known as CTI Compañía de Teléfonos del Interior, S.A. The company was founded in 1994 and is based in Buenos Aires, Argentina. AMX Argentina, S.A. operates as a subsidiary of America Movil S.A.B. de C.V.

Claro launched its 3G UMTS service over B2 (1900 MHz) and B5 (850 MHz) in November 2007 and in 2011 began advertising a HSPA+ upgrade as a "4G" service. The company has since launched 4G LTE services in 2015 on B4 (1700 MHz) and B28 (700 MHz) bands.
